## VI. 2019 BUDGET

We requested the same amount as we were given in 2018, \$31,500. The Town Board added an additional \$4,000.00 for 2019 to cover the shortfall we needed for joining V-Cat.

## VII. V-CAT APPROVAL AND SIGN AGREEMENT WITH WVLS

Kay made a motion to approve the V-CAT agreement with Wisconsin Valley Library System. Carol E. seconded. Motion carried.

Carol B. as President of the Wabeno Library Board then signed the agreement.

### VIII. V-CAT TIMELINE

A representative from WVLS came to look over our collection. The plan is to start implementing the process in February or March 2019. Cindy feels she will be able to catalog our collection into the system on her own.

### IX. WISCAT

It was necessary to pay for the WISCAT fee for 2019 because there will be overlap with the conversion.

## X. COMMENTS AND/OR CONCERNS AND/OR CORRESPONDENCE

Cindy requested permission to close the library on Saturday Dec. 22, 2018, the Board granted permission.

This Board would like to express their appreciation to the Town Board of Wabeno for their support of our library, and we especially appreciate the extra money allotted for us to reach our goal.
